In connection with the implementation of the project entitled "Design and development of an innovative solution - a drug from the group of GLP-1 receptor agonists in the treatment of type 2 diabetes" funded by the state budget from the Agency for Medical Research, Warszawskie Zakłady Farmaceutyczne Polfa S.A., is requesting bids for the **synthesis and supply of peptides.**

I. NAME AND ADDRESS OF THE BUYER

II. MODE OF INQUIRY

- 1. This inquiry is not subject to the provisions of the Act of September 11, 2019. Public Procurement Law (i.e. Journal of Laws of 2019, item 2019).
- **2.** Proceedings conducted by market discernment, in an expedient and economical manner in compliance with the rules:
 - 1) Getting the best results from given inputs;
 - 2) Optimal selection of methods and means to achieve the set goals;
 - 3) openness, fair competition and equal treatment of contractors.

III. DESCRIPTION OF THE SUBJECT OF THE INQUIRY

3.1. The subject of the price inquiry is the purchase and delivery of the following quantities of peptides:

IV. PLACE AND DATE OF DELIVERY OF THE PRICE INQUIRY

- **4.1.** The subject of the request must be delivered to the Buyer's registered office at the following address: Warszawskie Zakłady Farmaceutyczne Polfa Spółka Akcyjna, 31 Barska St, 02-315 Warsaw. Transport in conditions in accordance with the requirements specified by the manufacturer of the medicinal product.
- **4.2. Delivery time of the subject** of the price inquiry: **up to 60 calendar days** from the date of order.





4.3. Due to the fact that the time of delivery of the subject of the price inquiry is a criterion for the evaluation of bids, the implementation will take place in accordance with the submitted bid, but no later than 60 calendar days from the date of the order.

V. GENERAL REQUIREMENTS

- **5.1.** The buyer does not allow equivalent products.
- **5.2.** The buyer does not allow other quantities than those specified.
- **5.3.** The buyer does not allow partial bids.
- 5.4. The vendor, along with the delivery, will provide a certificate of analysis including: the result of HPLC analysis (purity above 95%), the result of HRMS (high-resolution mass spectrometry) analysis, a statement on the exchange of TFA counter ion for acetate ion.

VI. DESCRIPTION OF PRICE CALCULATION

- **6.1.** How to calculate the bid price: the price should be calculated net.
- **6.2.** Bids submitted in a currency other than PLN will be converted into PLN at the average exchange rate of the National Bank of Poland (https://www.nbp.pl/) on the closing date for submission of bids
- **6.3.** The price should include all costs associated with the preparation and execution of the subject of the request.
- **6.4.** The price submitted in the bid cannot be changed during the execution of the contract.

VII. DESCRIPTION OF THE CRITERIA THAT THE BUYER WILL BE GUIDED IN THE SELECTION OF THE OFFER

- **7.1.** When evaluating bids, the Buyer will be guided by the given criteria:
 - Price 80%,
 - Delivery time 20%,
- **7.2.** The evaluation criteria apply to both partial bids and bids covering all parts of the subject matter of the contract. Evaluation and thus scoring will be carried out individually for each part of the subject matter of the contract, regardless of whether the offer will cover all parts of the subject matter of the contract or will be a partial offer.
- **7.3.** The scoring of the bid will be done according to the formula:

$$O_P = P_C + P_G$$

Where:

O_P	-	offer scoring
P_C	-	number of points obtained in the criterion "Price"
P_G	-	number of points obtained in the criterion "Delivery time"

7.4. The number of points (P_C) in the criterion "Price" will be calculated according to the formula:

$$P_C = \frac{C_N}{C_R} * 80 \text{ pkt}$$

Where:

P_C - number of points for the criterion "Price"

C_N - of the non-rejected bids, the lowest total net bid price

C_B - total net price of the tested offer





Bids submitted in a currency other than PLN will be converted into PLN at the average exchange rate of the National Bank of Poland on the closing date for submission of bids.

7.5. The number of points (P_G) in the criterion "Delivery time" will be calculated according to the formula:

$$P_G = \frac{G_N}{G_R} * 20 \text{ pkt}$$

Where:

P_C - Number of points for the criterion "Delivery time"

G_N - Among the offers that were not rejected, the shortest bid delivery time

G_B - delivery time of the tested offer

By delivery time, the Buyer means the time counted in calendar days from the receipt by the Buyer of the Seller's confirmation of acceptance of the order for processing.

The bid will be rejected if the delivery time of the subject of the price inquiry is longer than 60 calendar days.

7.6. The most advantageous offer will be considered the offer from among the offers that have not been rejected, which in total will obtain the highest number of points. The maximum the Seller can obtain is 100 points. Calculations will be made to two decimal places.

VIII. PLACE AND DATE OF SUBMISSION AND OPENING OF TENDERS

- **8.1.** Bids must be submitted by the **deadline of 01.03.2024**.
 - in electronic form to: <u>barbara.wendolowska@polpharma.com</u> in the form of scans of documents or electronically signed documents.
- **8.2.** The deadline is determined by the date and time of receipt of the offer by the Buyer.
- **8.3.** Bids submitted after the deadline will not be considered.
- **8.4.** Buyer does not anticipate public opening of Bids
- **8.5.** The bidder may amend or withdraw its bid before the deadline for submission of bids.

IX. DESCRIPTION OF BID PREPARATION

- **9.1.** The Seller must prepare a single price offer in accordance with the model form attached as Appendix 1 to the request. Submitting more than one bid for a given part will result in rejection of all bids submitted by the Seller.
- **9.2.** The bid should be prepared in Polish or English,
- **9.3.** Bidders are required to carefully review the information contained in the Price Request.
- **9.4.** The bidder shall bear all costs associated with the preparation and submission of the bid.
- **9.5.** Until the deadline for submission of bids, the Procuring Entity reserves the right to amend or supplement the contents of this price inquiry.
- **9.6.** A bidder submitting a bid shall remain bound by it for a period of 60 calendar days counting from the deadline for submission of bids.





X. METHOD OF COMMUNICATION BETWEEN THE BUYER AND THE SELLER, AUTHORIZED CONTACT PERSONS

- **10.1.** In the proceedings, statements, requests, notifications and information shall be provided by the Buyer and Seller in Polish or English.
- **10.2.** All notices, statements, requests and information transmitted in electronic form shall require, at the request of either party, immediate confirmation of receipt.
- **10.3.** In the absence of an acknowledgement of receipt of correspondence by the Seller, the Buyer shall presume that the correspondence sent by the Buyer to the email address provided by the Seller has been delivered to the Buyer in such a way as to enable the Buyer to become acquainted with its contents.

- **10.5.** In correspondence related to this request, the Seller should use the procedure number: Price Inquiry No. **SEMA/32/PR48126/2024.**
- **10.6.** The person authorized to communicate with the Seller is Barbara Wendolowska.
- **10.7.** No oral or telephonic information, explanations or answers are provided to inquiries addressed to the Buyer.
- **10.8.** Any questions regarding this inquiry should be submitted by email to the address indicated above no later than 3 days before the deadline for submission of bids.
- **10.9.** Responses to questions and the detailing of the Inquiry resulting from questions from potential Sellers will be sent to the entity that sent the question.

XI. PROCEDURE FOR EVALUATION OF TENDERS AND ANNOUNCEMENT OF RESULTS

- **11.1.** In the course of examination and evaluation of bids, the Buyer may request from the Seller supplements (if this does not violate competitiveness) and clarifications regarding the content of submitted bids. He may also request correction of obvious mistakes and calculation errors.
- **11.2.** The Buyer reserves the right to check, in the course of evaluating the offer, the credibility of the documents, statements, lists, data and information presented by the Sellers.
- 11.3. If two or more Sellers obtain the same number of points, the bid with the most favorable environmental and climate impact will be selected. For this purpose, the Buyer has the right to call on the Bidders whose bids received the highest final number of points to supplement their bids by providing the information indicated by the Buyer regarding the environmental impact of the subject of the bid.
- **11.4.** The Procuring Entity reserves the right to cancel the procedure without giving any reason.
- 11.5. In the event of cancellation of the procurement procedure, suppliers shall not be entitled to claim reimbursement of the costs of participation in the procedure.
- **11.6.** The Contracting Authority's withdrawal from the conclusion of the contract in the event of notification to the contractor of the selection of his tender shall not be the basis for claims for costs incurred for participation in the procedure.
- **11.7.** In the course of evaluating submitted tenders, the Contracting Authority may request clarifications from contractors regarding the content of the documents submitted by them.
- **11.8.** If a bid does not contain all the required elements, the Contracting Authority may, in justified cases, call on the Contractor to supplement it.
- 11.9. The Contracting Authority reserves the right to negotiate bids with the Contractor whose bid has the highest number of points, especially if the price offered by the Contractor exceeds the budget allocated by the Contracting Authority for the execution of the contract. Negotiations





may have several successive rounds with the possibility of inviting the bidder to submit an updated bid after each round of negotiations.

XII. OTHER INFORMATION

- **12.1.** The bidder shall bear all costs associated with the preparation and submission of the bid.
- **12.2.** Until the deadline for submission of bids, the Procuring Entity reserves the right to amend or supplement the contents of this price inquiry.
